Hearing on Treaty to end Discrimination Against Women Worldwide

NOW applauds Sen. Dick Durbin (D-Ill.) for chairing a first-ever Judiciary Committee hearing Nov 18, 2010 on ratification of the U.N. Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). Eight years have lagged since the last hearing for the human rights treaty signed by President Jimmy Carter in 1979.

Women around the world have waited more than 30 years for the U.S. to ratify this treaty. In an age when women can be blamed and then stoned to death for being raped, forced to wear burkas, denied rights to education and free movement, and treated as property (and sometimes as animals), it is unconscionable for a vocal reactionary minority in our Congress to keep our country sitting on the sidelines. Women are 70 percent of the 1.3 billion people living in poverty worldwide, primarily due to their subjugation.

To date, 185 countries have ratified CEDAW, and even though the United States helped draft the treaty, it is the only industrialized country that has yet to ratify. The other six countries that have refused are Iran, Sudan, Somalia, Nauru, Palau and Tonga.
