DEAR PEGGY,
HOW ARE YOU? FINE I HOPE. I GOT YOUR INFO FROM A FRIEND OF MINE. SHE SAID YOU MIGHT BE ABLE TO HELP ME WITH MY SITUATION. IN OCT. 2011, I HAD A MASSIVE STROKE ON MY LEFT SIDE. I WAS IN A COMA FOR A WHILE. I DON'T KNOW HOW LONG. WHEN I WOKE UP I COULD NOT TALK FOR A WEEK. AFTER THAT, I TALKED. FROM 10/20/11 TO 12-20-11, I WAS IN A TOTAL OF (3) HOSPITALS. THEN I WAS DISCHARGED. I CAME BACK TO THE PRISON AND WAS PUT IN THE INFIRMARY FOR (2) WEEKS. THEN I WAS PLACED BACK ON MY UNIT.

I WAS APPROVED FOR PHYSICAL THERAPY 3X'S WEEKLY FOR (6) WEEKS. AFTER (2) VISITS, I WAS DENIED TRANSPORT. THE PRISON HAS A POLICY THAT INMATES GOING FOR OUTSIDE MEDICAL HAS TO WEAR SHOWER SHOES. I CAN NOT WEAR THEM BECAUSE THERE IS NOT ANY SUPPORT TO WALK, ~~THE~~ MY LEFT SIDE IS NUMB AND MY FOOT FLOPS OVER. EVEN THOUGH I CAN MOVE (L) LEG AND ARM, THEY ARE NUMB. I HAVE BEEN UP THE CHAIN OF COMMAND ON THIS, TO NO AVAIL.

I WAS (L) HANDED AND NEEDED TO LEARN TO WRITE (R) HANDED.

THIS IS MY 5th STROKE IN (8) YEARS OF PRISON TIME.

ALSO, I HAVE PTSD SEVERLY AND NOT ON ENOUGH MEDS. ONLY A PART-TIME PSYCHE DOC FOR ENTIRE PRISON. WAITING LIST IS ONE YEAR. NO COUNSELING TO SPEAK OF.

I'VE BEEN ABUSED FOR 50 YEARS ALL THE WAY AROUND. I HAVE 7½ YRS MORE TO DO FOR SOMETHING THAT SHOULD HAVE BEEN LESS TIME.

I WANTED A COPY OF MEDICAL RECORDS FROM 10/20/11 TO MAR 20, 2012 TO BE SENT TO MY SISTER: MY MEDICAL POWER OF ATTORNEY. THE PRISON CHARGES 50¢ A PAGE. EVEN WHEN I GET A FEW DOLLARS, THE STATE TAKES DEDUCTIONS. EVEN THE FACT THAT I'M A WARD OF THE STATE, MY FAMILY WAS LIED TO BY PRISON OFFICIALS.

I KNOW I'M RAMBLING, PLEASE EXCUSE THE BRAIN DAMAGE.
